### Water/Sewer Rate Increase

- (1) For each 3/4 inch water meter, a minimum charge of \$12.25 per month for which the customer is entitled to 1,000 gallons of water. The customer shall pay \$4.42 for each additional 1,000 gallons of water used, up to a total of 5,000 gallons; and for each 1,000 gallons thereafter there shall be a charge of \$4.77.
- (2) For each 1 inch water meter, a minimum charge of \$32.03 per month for which the customer is entitled to 5,000 gallons of water. The customer shall pay \$4.42 for each additional 1,000 gallons of water used, up to a total of 7,500 gallons; and for each 1,000 gallons thereafter there shall be a charge of \$4.77.
- (3) For each 1  $\frac{1}{2}$  inch water meter and 2 inch meter, a minimum charge of \$50.42 per month for which the customer is entitled to 7,500 gallons of water. The customer shall pay \$4.42 for each additional 1,000 gallons of water used, up to a total of 15,000 gallons; and for each 1,000 gallons thereafter there shall be a charge of \$4.77.
- (4) For each 4 inch water meter, a minimum charge of \$79.22 per month for which the customer is entitled to 20,000 gallons of water. The customer shall pay \$4.42 for each additional 1,000 gallons of water used, up to a total of 40,000 gallons; and for each 1,000 gallons thereafter there shall be a charge of \$4.77.

Monthly charges for water use by users who are not residents of the City of Goessel shall be based upon the size of water meter installed and amount of water used, and shall be charged a sum equal to twice the charge assessed to a resident of the City of Goessel.

In addition to the charges for water established above in parts, there shall be a surcharge for the purpose of servicing and improvements to the municipal water system and to provide for maintenance and upkeep thereon, based on the size of the water meter installed, which shall be billed and shall be payable at the same time as the regular water bill is due and payable as follows:

- (a) For each ¾ inch or 1 inch water meter, a charge of \$8.00 per month.
- (b) For each 1 ½ inch or 2 inch water meter, a charge of \$12.00 per month.
- (c) For each 4 inch water meter, a charge of \$16.00 per month.
- (1) For all contributors, monthly user charges will be based on the <u>average monthly water usage</u> determined during the months of January, February and March, and each contributor's <u>average month water usage</u> shall be established on the 1<sup>st</sup> day of May each year. In the event a contributor has not established a January, February, March average, his or her monthly user charge shall be the average charge of all other residential contributors. In the event a contributor does not use city water, his or her monthly user charge shall also be the average charge of all other residential contributors.
- (2) The minimum charge per month shall be \$22.00. In addition, each contributor that is located in the city shall pay a user charge rate for operation and maintenance, including replacement, of \$.30 per 100 gallons of water (or wastewater) and each contributor that is not located in the city shall pay a user charge rate of \$.40 per 100 gallons of water (or wastewater), all as determined in paragraph (b) of this Section. Further, every contributor shall pay a sewer maintenance examination fee of \$2.00 per month for each meter used by such contributor.
